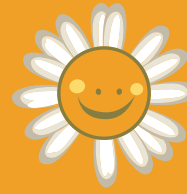

## Tell us what you think

It is Cancer Fund for Children's responsibility to ensure that there is a system in place to record and investigate any feedback that is critical of our work and requires a response. This will be dealt through the complaints section of this policy. We are committed to ensure that children/adults, their families and members of the public are aware of their rights throughout the complaints process.

## Feedback

Feedback is always welcome, and we hope that any child, adult, family member, volunteer, contractor or a member of the public will provide us with feedback about our service. This is information that can be used to help us make improvements and ensure we maintain high standards.

If you do have feedback about any aspect of our work, you can contact Cancer Fund for Children in writing, by telephone or email. Please give as much information as possible and let us know how you would like us to respond, providing relevant contact details.

## What happens next?

Once received, our aim is to always acknowledge your complaint within 14 days. If this is not possible, we will explain why and provide a new deadline.

## What if the complaint is not resolved?

If you are not happy with our response to your formal complaint, you should submit a formal written appeal within 14 days, outlining in detail your reasons for your appeal. This will be forwarded to the Chief Executive who will appoint the most appropriate person to deal with the appeal. This may be a member of the Executive Leadership Team, who was not the decision maker with respect to the original complaint. Alternatively, the Chief Executive may, at their discretion, appoint an external reviewer to consider the appeal.

A response will be given within 14 days of the date of receipt of the written appeal.

If we cannot respond within the 14 days, we will explain why and provide a new deadline.

## Your personal information

If you use our complaints procedure, you are agreeing that we can use any personal information you send us for the purposes connected with your complaint. We will only give your personal information to other people and organisations if you have given us permission.
